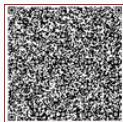

TERMS AND CONDITIONS

1. The award is open to the Specialists from various Medical, Nursing and Gerontology institutions from India within one year of passing the MD/DNB/PhD/MSc examination in the branches of Pre, para and clinical branches of MD (Allopathy), Dentistry, Nursing & Gerontology.
2. The study must have been done involving older people (>60years)
3. The last date for submission of the application for the award is October 15, 2025.
4. The award shall comprise of a cheque of Rs.10,000/- along with a Certificate
5. Soft copy of the duly completed application form (as per Annexure –I) along with various enclosures (as per Annexure – II) should be sent to the office of The Geriatric Society of India duly countersigned by the Chief Supervisor of thesis/dissertation, Head of the Department and by the Head of the Institution to secretary2025.gsi@gmail.com
6. The thesis / research work must be original and all illustrations, diagrams, tables, should have been prepared by the candidate himself / herself.
7. THE THESIS WILL BE JUDGED ON FOLLOWING POINTS
 - a. Is the research topic innovative and original? 20
 - b. Study design, sample size and methodology 20
 - c. Relevance of the thesis topic 10
 - d. Adequacy of the review of literature and discussion in the light of related studies 10
 - e. Whether conclusions drawn are valid? 10
 - f. Overall preparation of the manuscript 10
 - g. Practical implications for the future 10
 - h. Published in Journal indexed in Scopus/ Web of Science- 10
 - i. TOTAL MARKS 100**
8. The successful candidates shall be informed at least one month before the scheduled dates of the Annual Conference of The Geriatric Society of India to enable them to receive the said award.
9. The award shall be conferred during the ensuing Annual Conference of GSI. Hony. Secretary shall inform the successful applicants to present salient features of their thesis / research work for about 10 minutes during the GSICON.
10. The winner shall be provided Complimentary registration to attend GSICON for one day, however, they have to make their own arrangements for stay and travel.
11. In case, the candidate selected for award fails to make a presentation during the GSICON, then award shall be conferred in subsequent conference.
12. The duly completed applications must be sent to the Office of GSI so as to reach on or before October 15, 2025 of the respective year. Incomplete applications shall be summarily rejected.

- Self-attested photocopy of the Degree. In case, degree has not been awarded, then a certificate of having passed the **MD/DNB/PhD/MSc** examination in Medicine & Nursing and Gerontology.
- Payment of **Rs.500/-** in favour of 'Geriatric Society of India' as the processing fee by using QR code and share the screen shot of the same.
- One soft copy of the detailed write up giving details of thesis work should be submitted in the following format or the copy of article if published in Journal indexed in **SCOPUS** or **WEB OF SCIENCE**
 - Abstract, introduction and brief review of relevant literature, Lacunae in the existing literature, Detailed Materials and Methods, Results, Discussion, Summary and Conclusions, References. The entire thesis / research project should not be sent.
 - The write-up should be typed on A-4 sized paper in single spacing, Times New Roman, Font Size 12, maximum 3000 words including the Abstract and References, but excluding Tables and Figures. A maximum of 5 Tables and 4 Figures may be included. References should be typed in Vancouver Style.
